PUBLIC NOTICE

The last date for submitting online applications on e-district portal has been extended upto 31/1/2017.

The Department for the Welfare of SC/ST/OBC/Minorities has invited online applications through e-district portal of Government of NCT of Delhi w.e.f 01/12/2016 for following scholarship schemes from the students belonging to SC/ST/OBC/Minorities category in National capital Territory of Delhi:-

1. Reimbursement of tuition fee for SC/ST/OBC/Minorities category students studying in private schools in Delhi (Class 1st to 12th)
2. Financial Assistance for purchase of stationery to SC/ST/OBC/Minorities category students (Class 1st to 12th)
3. Scholarship/Merit scholarship to SC/ST/OBC/Minorities category students studying in schools
4. Scholarship/Merit scholarship to SC/ST/OBC/Minorities category students studying in colleges/professional/technical institutions.
5. Dr. B. R. Ambedkar State Toppers award to SC/ST/OBC/Minorities category students
6. Post Matric Scholarship for OBC students (Centrally sponsored scheme, Ministry of Social Justice & Empowerment, Government of India)
7. Pre-matric Matric Scholarship for OBC students (Centrally sponsored scheme, Ministry of Social Justice & Empowerment, Government of India)

i. The lists of all recognised schools/colleges/ educational institutions in Delhi received from concerned administrative departments have been integrated on the portal. However, if any recognised school/ college/ educational institution is still not integrated on the portal, the schools/colleges/educational institution may approach their respective administrative department for inclusion of the name on the portal, so that no student remains be deprived of the benefits of scholarship schemes.

ii. The disbursement of the scholarship amount will be made through PFMS mode using Aadhaar number of the applicants. Therefore, Aadhaar number of student is required while applying online application on e-district portal.

iii. The list of banks and their branches are available on the portal required for filling the application forms. If any applicant found that the details of her/his bank is not available on the portal, the applicant may send a copy of the cancelled cheque/ bank pass book (mentioning MICR & IFSC code) of the applicant to this office through e mail at dscstschscheme.delhi@gov.in so that the same may be integrated on the portal.

iv. Login IDs and pass words of all schools/colleges/educational institutions for authentication and verification of data of respective applicants will be made available to the nodal officers of the schools/colleges/educational institutions through their administrative departments in due course of time. All schools/colleges/educational institutions should appoint a nodal officer and authorise him/her to authenticate and validate the data of the applicants of their respective school/college/educational institution.

v. This is informed that applicants are required to upload all relevant documents on the portal. There is no need to submit the acknowledgement/receipts, application or any other documents in the Department for the welfare of SC/ST/OBC. The same may be submitted in their concerned educational institutes for future references.

vi. The students who are residents of Delhi but studying in the educational Institutions, situated outside Delhi (only applicable for scheme number 4 and 6 above), may apply online and take a print out of the filled in application form and get it verified from the concerned institute in the prescribed format of certificate available as part of online application form and further upload it on the portal. Thereafter, they should submit hard copy of application form alongwith required documents in the Department for the Welfare of SC/ST/OBC/Minority, B Block, Vikas Bhawan, I. P. Estate, New Delhi-2 within 30 days by registered post/courier only addressed to Deputy Director (Scholarship), Department for the Welfare of SC/ST/OBC, B Block, Vikas Bhawan, IInd Floor, I P Estate, New Delhi-110002.

vii. The applicant should upload the income certificate (if required, as per scheme), valid on the day of submitting online application on the portal.
