15. Multidisciplinary / interdisciplinary

Shri Ram College of Commerce specializes in Commerce, Economics, and Management education. These disciplines are inherently interdisciplinary and multi-disciplinary, as their knowledge, literature, and research emanates as well as draws from disciplines such as mathematics, language, communication, psychology and computer Nonetheless, the College further recognizes science amongst others. the importance of inter-disciplinary and multi-disciplinary education with a special focus on nurturing values, ethics, creativity, scientific & systemic approaches, critical thinking, and problem-solving skills among students. Therefore, the College embraces a multidisciplinary/interdisciplinary approach in line with the Choice Based Credit System (CBCS) and National Education Policy (NEP) 2020. In addition to Commerce and Economics, the College also has dedicated departments namely - Hindi, English, Mathematics, Environment Science, Computer Science, Physical Education and Sports, and Political Science. For the undergraduate programmes of B.A. (Hons.) Economics and B.Com. (Hons.), students under the CBCS framework were being offered diverse generic electives and ability enhancement courses. Similarly, for students admitted under the NEP Framework (2022-23 onwards) are being offered Skill Enhancement Courses, Ability Enhancement Courses, Value Addition Courses in addition to the Discipline Specific Core and Discipline Specific Electives. hence providing multidisciplinary eduction in the Institution. These courses cover a wide gamut of topics ranging from gender, society and values, communication, health, and politics, thereby providing exposure to students of other disciplines. The Global Business Operations programme also offers various courses to promote professional ethics and cultural understanding, such as 'Social and Ethical Issues in Business', 'Managing across Cultures', and 'International Corporate Governance'. Even before the NEP 2020 mandate, SRCC has been proactively taking various steps towards the integration of Humanities and Social Sciences with Science and Technology through value-added/add-on courses being offered since 2018, thereby adding flexibility and innovation to the University's prescribed curricula. Additionally, the College further expands on the mult-disciplinarity of its education by offering diverse add-on courses to its students such as 'Certificate Course in Foreign Language-French' in collaboration with Department of Germanic and Romance Studies, University of Delhi with Course duration of 125-150 hours and 'Certificate Course in Fundamental and Technical Analysis'

by BSE Institute for about 30 hours. In view of NEP 2020, the College has also launched additional multidisciplinary short-term courses in collaboration with the industry and professional bodies on themes such as Indian heritage, ancient Indian Knowledge, legal literacy, practical knowledge about securities markets, and emotional intelligence amongst others.

16.Academic bank of credits (ABC):

The NEP 2020 envisions a multiple entry-exit structure where students will have the flexibility of multiple entry-exit from programmes and the ability to transfer credits among recognized Higher Education Institutions (HEIs) globally. This is envisaged through the implementation of Academic Bank of Credits (ABC), which will store academic credits that students accumulate from various HEIs both in India and abroad. Being a constituent College University of Delhi, the College follows the extant rules, guidelines and procedures implemented by the University on the same. At present, all students mandatorily register on the ABC portal (www.abc.gov.in) wherein they are given an ABC ID which is linked to the Digilocker of the student. The ABC ID is further provided to the University of Delhi to link it with the students academic record with their digilocker account. The University provides access to the Samarth Portal to the College towards managing the credits accrued from various courses.

17.Skill development:

One of the key goals of the National Education Policy (NEP) 2020 is to broaden the scope and enhance the accessibility of vocational education in India through the National Skills Qualifications Framework (NSQF). Shri Ram College of Commerce (SRCC) provides a variety of vocational courses as short-term certificate programs for both undergraduate and postgraduate students. These courses are developed in collaboration with industries, professional organizations, and governmental bodies. Furthermore, SRCC plans to offer these vocational courses in a blended format, combining both online and offline delivery methods, to maximize reach and accessibility for students. The college has a dedicated Value-Added Courses (VAC) Committee that regularly introduces courses designed to close the gap between industry demands and academic offerings. These courses are thoroughly developed through formal deliberations to ensure they effectively enhance skills. Recent offerings from the VAC Committee include a 'Certificate Course in Foreign Language-French', in collaboration with the Department of Germanic and Romance Studies at the University of Delhi, and a 'Certificate Course in Fundamental and Technical Analysis' provided by the BSE

Institute. To further align with contemporary industry trends, courses covering topics such as Artificial Intelligence, Robotics, 3D Printing, Internet of Things, and Blockchain & Cryptocurrencies are also available under the VAC umbrella. SRCC facilitates enriching learning experiences through various academic webinars, seminars, and workshops, and encourages students to engage in research and case studies with the support of faculty mentors. This research is often published in 'Strides', a journal dedicated to SRCC students. SRCC also hosts vibrant student-driven societies like The Economics Society, The Computer and Mathematics Society, The Commerce Society, and Vittshala-The Financial Literacy Cell. The Shri Ram Incubation Centre (SRIC) fosters innovation and entrepreneurial skills among students and faculty. Additionally, the college has launched educational initiatives such as the 'One-week IQAC Faculty Lecture Series' and 'Distinguished Lecture Series', which cover a wide range of contemporary themes. Outreach-committed societies such as the NSS, Connecting Dreams Foundation, and Enactus offer students multidisciplinary insights. Through annual conferences and festivals like 'Business Conclave' and 'Crossroads', students gain practical experience in organizing public events. SRCC also facilitates interactions with leading figures from academia, industry, politics, sports, and the arts, enhancing students' skills and perspectives.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

As a constituent College of the University of Delhi, SRCC employs the Under Graduate Curriculum Framework (UGCF) of the University of Delhi based on National Education Policy. The UGCF focuses on Programmes Outcomes, Graduate Attributes, Course Specific Learning Objectives and Learning Outcomes for each of its Discipline Specific Courses, Discipline Specific Elective Courses, Generic Elective Courses, Skill Enhancement Courses, Ability Enhancement Courses and Value Addition Courses. Faculty Members, in addition to the University Curriculum, also focus on the teaching methodology aligned with the outcomes for the subject, adopting an eclectic approaching merging chalk and talk, ICT based teaching, and case based teaching amongst others. This is further solidifed through the tutorial system where concepts are discussed n depth on a one-to-one basis. Similarly, the Learning Objectives and Outcomes are measured through the assessment and evalution, including practical exercises noted in the curriculum

20.Distance education/online education:

Being a constituent College of the University of Delhi, the College offers its undergraduate and postgraduate programmes in the regular physical mode as per the extant programme curriculum. Nonetheless, understanding the importance of online education, especially its role in making education time and resource convenient, the College endeavours to offers its value added courses in online mode. Further, the College holds several lectures/discussions in online mode. For example, a Webinar was held on November 12 and 13 by SQAC, SRCC, the student body of IQAC, SRCC in online mode. Similarly, SRCC with the Department of Commerce, University of Delhi, the Internal Quality Assurance Cell, SRCC and Institute of Life Long Learning (ILLL), University of Delhi organised a One-Week Online Short Term Programme on Indian Knowledge System from January 16-21, 2023.

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

In view of the programme outcomes, course outcomes and learning objectives articulated in the University of Delhi's curriculum, the curriculum in the College is delivered through a continuous, planned, structured, and stakeholder-oriented approach. Firstly, the College Handbook and Website offer up-to-date, comprehensive information on different programs, courses, and their curricula. Secondly, time tables are designed to ensure a suitable teacherstudent ratio and efficient use of resources, especially resources such as computer labs for efficient curriculum delivery. Dedicated infrastructure and academic resources are regularly improved as per curricular requirements. Thirdly, subject specific meetings relevant to a course are convened to discuss the general contours of the curriculum delivery, including teaching-learning strategies, delivery structure and pace, integration of current and cross-cutting themes, and internal assessment, among other aspects. To increase efficacy, Faculty members attempt to innovate in a number of areas related to curriculum delivery, such as

andragogy and evaluation techniques, within the general framework. Students' learning, knowledge, and talents are greatly enhanced by the democratic and participatory teaching-learning atmosphere in classrooms, which is firmly complemented by highly tailored tutorials, assuring successful curriculum delivery. The College's curriculum delivery is further reinforced via value-added/add-on courses, speaker events, lecture series, and seminars. Apart from the feedback that students provide in real time throughout the teaching-learning process, the College regularly gathers feedback from stakeholders and matches the andragogy to bridge gaps where required.

At the College, strategies like flipped classrooms are used to support students in self-evaluation on a regular basis, guaranteeing their holistic growth.

Even though the College student base comprises achievers who excel academically, proactive efforts are undertaken to establish and ensure a peaceful and equitable learning environment that takes into account students' varying learning levels:

- 1. Within the classroom, Faculty evaluate students' learning levels and align their andragogy to maximize learning through participation and concurrent feedback.
- 2. Regular evaluations assist in determining whether students understand the curriculum's delivery. Academically slower learners are recognized, and special focus is accorded to accelerate their learning through ongoing two-way communication and feedback on their performance.
- 3. For academically slow learners, extra lessons, individualized mentoring, remedial classes, and other programs are offered to help them advance their learning.
- 4. Advanced Learners are provided additional avenues to ensure knowledge progression, skill acquisition and augmentation, including value-added courses, industry-led courses, publication opportunities, and active participation in student societies.

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

The goal of SRCC's highly learner-oriented teaching-learning approaches is to enhance students' horizons with an emphasis on knowledge that integrates value systems, social understanding, abilities and qualities like creativity and critical thinking. The ICT Infrastructure of the College supports its multifaceted andragogical teaching- learning method, which results in strong graduation outcomes. Apart from conventional teaching approaches such as lectures and chalk-and-talk, a strong tutorial system that facilitates individualized small-group interactions between students and instructors is used to implement personalized learning. In contrast to one-way communication, SRCC emphasizes vaad, vivaad, and samvaad. Several ICT-based blended learning techniques are used, including software-based learning, webinars, films, and presentations.

Additionally, case studies, group discussions, and debates are used in participatory teaching and learning. Further, Faculty employ newer teaching techniques including flipped classrooms, in which students actively participate as thinkers, researchers, and learners. Through projects, field and industry visits, and the students' increased participation in a variety of co-curricular and extracurricular activities, experiential learning and engagement-based teaching are integrated since Faculty members actively assist students in subjects, research, and career trajectories, alternative teaching strategies including crossover teaching are also commonplace.

SRCC provides an ICT- integrated teaching-learning environment through its Wi-Fi enabled campus and ICT enabled classrooms.

Faculty members use ICT-driven teaching-learning methodologies that improve the delivery of the curriculum by utilizing software-based learning, films, webinars, and presentations. Courses such as Accounting and Financial Management are taught to students using specialized software like Tally Prime. In addition, applications such as Microsoft Excel and programming languages like R and Python are taught in classes. Further, library resources such as E-journals, E-Books and databases such as Prowess IQ are employed for teaching-learning, to ensure wider perspectives and applied learning for students.

The College has institutionalised a progressive student-centric open, transparent, equitable and robust Internal Assessment (IA) mechanism, detailed below:

- 1. The extant University of Delhi guidelines regarding IA are proactively displayed on the College Website and Handbook of Information to ensure information dissemination and awareness. Students are also apprised of the same in classrooms and tutorials.
- 2. The IA Schedule is planned as per the programme curriculum requirements and the University Academic Calendar. Students are apprised of the modes, frequency and schedule of IA in advance at classroom and tutorial levels by Faculty.
- 3. Instead of a point-of-time single-assessment approach, multi-method approach is employed during the semester through regular assignments, presentations and group-discussions amongst other methods to ensure continuous evaluation which helps students develop progressively and provides them with several avenues and opportunities of being evaluated.
- 4. Post assessment, Faculty discuss the marking and scope of improvement with students. Students are given fair and reasonable opportunities to represent themselves in such interactions.

Nonetheless, in cases where grievances arise, students can use the institutionalised IA Grievance Redressal Process, communicated to them well in advance. The IA marks of students are also displayed on the Smart Prof and College website to ensure transparency of information. The Internal Assessment Monitoring and the Internal Assessment Moderation Committees further considers and recommends action on Internal Assessments, including grievances, if any.

1. The IA results are notified in the Classrooms and Tutorials

- where Faculty discuss the assessment with students. Students are given fair and reasonable opportunities to represent themselves in such interactions.
- 2. The College notifies the IA Grievance Redressal Mechanism timely through the College Website and SmartProf Student Management System. Students are provided with reasonable time to register their IA issues on the SmartProf system. Grievances registered are promptly notified to the concerned Faculty.

A time-bound process is adopted wherein Faculty member have to resolve IA grievance(s) pertaining to their course on the SmartProf portal. Students are notified of the decision of the Faculty towards the IA grievance.

At the next level, there are College-level Committees such as the Internal Assessment Monitoring Committee and the Internal Assessment Grievance Committee, for resolution of IA grievances already addressed, but not resolved at individual Faculty level, which take appropriate steps to examine and resolve such issues.

Student progression is analysed to understand how well the programme and course outcomes have been achieved. Further, feedback is sought from stakeholders such as recruiters visiting the campus who help assess whether the students have the desired graduate attributes, and the knowledge and skill levels commensurate with the programme and course outcomes. Through such feedback, appropriate planning and implementation in form of additional value-added courses, guest lectures, speaker sessions, and field visits amongst other are undertaken to achieve the expected outcomes.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning. viz., classrooms, laboratories, computing equipment etc.

SRCC proactively evaluates and ensures adequacy of its infrastructure in anticipation of stakeholder's requirements and expectations, within the regulatory constraints imposed by its heritage building status and classification as an 'Old College,' rather than a 'General College'. SRCC's Teaching-Learning and Research Infrastructure comprises physical and digital mediums, to facilitate the multi-dimensional teaching-learning. Despite increased student intake over past few years, SRCC has managed to ensure its infrastructure and physical facilities for teaching-learning by taking several steps such as constructing additional temporary structures, remodelling existing spaces, and extending its time-table. Salient points include:

- Each classroom is centrally air-conditioned and enabled with three-panel greenboards, podiums, overhead Wi-Fi, and VGA enabled LCD projectors.
- Post Graduate Diploma in Global Business Operations (PGDGBO) classrooms with AV system and smart podiums.
- Two smart classrooms are equipped with lecture-recording systems.
- The Research and Tutorial block has fifty-four airconditioned, Wi-Fi-enabled rooms with green boards and seating for approximately fifteen students. It also has important offices such as Placement Cell and the Counselling Service.
- The automated College Library is a three-storey, centrally air-conditioned, Wi-Fi- enabled structure that seats about 300 people.
- SRCC is differently friendly and inclusive. The College Library houses the Resource Centre for Visually Challenged equipped with enabling technology to empower divyang students.

To ensure quality avenues of co-curricular and extra-curricular development, and engagement with industry and community, the College has state-of-the-art cultural and sports infrastructure.

The College has amongst the best-in-class renovated and modernized Auditorium, named as, "Shridhar Shriram Auditorium", with in-built hi-tech sound and lighting systems, congenial acoustic systems, live streaming, Wi-Fi enabled presentation facility, automated projection, partition and modern Green Rooms.

For hosting important co-curricular and extra-curricular events such as guest lectures, group discussion, international programmes, speaker sessions, and symposia amongst others, the College has an air-conditioned ICT-enabled Seminar Room.

For sports and other large audience or VIP events, the College has a SRCC Sports Complex comprising a multipurpose Indoor Sports Stadium of international standards and an outdoor sports field. The Sports Stadium has a multipurpose sports hall with wooden planks for Badminton, BasketBall, Volleyball, Judo and Wrestling, and separate rooms for chess and table tennis. SRCC is also one of the few colleges in the University of Delhi to have a swimming pool facility (presently under maintenance).

The Sports Complex also houses the College's fitness center/gymnasium which also holds classes for kickboxing, yoga and aerobics. SRCC has several lawns adorned with large number of diverse trees and flowers, where yoga and cultural activities are held.

Network & Connectivity:

SRCC is provided a Main Internet Connection by the University of Delhi. While the College is already fully Wi-Fi Enabled, regular upgradation of the system is done to ensure high speed connectivity and access. SRCC has set up a parallel line in addition to the Main Internet Connection provided by the University to ensure seamless access even in cases of failure of the Main Line. Periodic checks are done on the network infrastructure such as routers to ensure their optimal functionality.

Depending on their cost and scale, such recommendations may be further placed before the Finance Committee

and/or SRCC Governing Body for their consideration. Further, being a stakeholder driven institution, at their request, the Principal also constitutes specific committees to look at matters of infrastructure from time to time.

Physical Infrastructure is managed by the College Administration to ensure cleanliness, hygiene, water supply, electricity, and security. AMC are awarded to vendors for maintenance, upkeep of hardware, software and network systems. A Sports Committee looks at the maintenance of sports complex. Further, outsourced staff (plumber, electrician, sweepers, and gardeners) ensure regular maintenance of the infrastructure.

Academic and Support Infrastructure

The allocation of classrooms, computer-labs and tutorial rooms for teaching-learning is done by Timetable Committees through established procedures and practices. Additionally, appropriate committee(s) may provide recommendations for the further expansion and remodelling of existing space. The Library Committee provides recommendations on matters of Library Infrastructure. The Computer Committee gives recommendations on matters of IT facilities for utilising support infrastructure such as Seminar Room or Auditorium. For organising events, there are established procedures.

Post Audit, the Auditor's Reports, alongside the Final Accounts for the Financial Year, are placed before the Finance Committee for its consideration. Post recommendation of the Finance Committee, it is presented to the Governing Body of the College for thorough deliberation and approval. This transparent and accountable approach underscores the College's steadfast dedication to fiscal prudence and governance excellence.

Through proactive discussions amongst its diverse members, the IQAC SRCC, in consonance with the best practices in higher education, has established processes and norms for ensuring effective teaching-learning in the College. From time to time, teaching learning processes, structures & methodologies of operations and learning outcomes are deliberated upon in the IQAC, SRCC. For example, the IQAC set the norms for hiring of faculty members in the College's self-financed PGDGBO programme. Other notable initiatives include the expansion of value-added courses following a thorough review of the academic curriculum, as well as the encouragement of regular Subject Meetings within College Departments to foster knowledge exchange and academic enhancement. Moreover, in its endeavour to foster a culture of research excellence, the IQAC recommended the expansion of the SRCC's "Centre for Academic Excellence" scheme, aiming to broaden its scope and facilitate enhanced reimbursement of expenses, thereby furthering research initiatives within the institution. These decisions were undertaken based on the reviews of the existing frameworks in the College.

Similarly, the IQAC from time to time considers avenues where quality initiatives could be considered. The outcomes of such reviews are policy recommendations, in addition to the organisation of activities, events, and programmes towards ensuring that the necessary quality initiatives be undertaken. For instance, the IQAC recommended the minimum attendance of students to be 75% for availing College benefits to further enhance teaching-learning in the College. Resultantly, incremental improvement in the attendance have been noted.

SRCC excels in waste management by maintaining robust systems for handling degradable and non-degradable waste, adhering to strict environmental standards. SRCC implements stringent source segregation to ensure effective initial sorting, critical for efficient processing. SRCC's Sanitization Park features NADEP composting pits for processing organic waste like food scraps and garden trimmings into high-quality compost. This compost is used for campus landscaping, and excess is sold through a partnership with the Centre for Green Initiatives, promoting sustainability. Paper waste management is conducted in collaboration with Greenobin Recycling Private Limited, focusing on transforming

paper waste into recycled products such as notebooks, which are reintegrated into the college's supply chain. Additionally, SRCC has established a partnership with Delhi MSW Solutions Ltd. (DMSWSL) for the disposal of Municipal Solid Waste and with M/s Shiv Shakti Metals for e-waste management. The institution also practices liquid waste management by using AC condensate for groundwater recharge through its rainwater harvesting system, underscoring its commitment to water conservation. SRCC ensures compliance with regulations for electronic waste, ensuring proper collection, sorting, and recycling by certified recyclers. Overall, SRCC's waste management practices demonstrate a comprehensive and sustainable approach to environmental stewardship, reinforcing its commitment to ecological responsibility and sustainability.
