## APPENDIX - I CRITERIA FOR ADMISSION (Bachelor in Economics)

SL.	Eligibility Categories	Rationale for the eligibility criteria
1	Candidates from all the streams Viz. humanities, science and commerce will be treated at par for the propose calculating cut-off percentage.	
2	An applicant must obtain at least 70% marks in Mathematics (equivalent to CBSE 12 <sup>th</sup> standard Mathematics) to be considered for admission to B.A. (Hons.) Economics First Year. This condition is applicable only for General Category students and not for OBC/SC/ST and Pwd Category Students.	Mathematics is an essential prerequisite for modern Economics. A score of 70% in Mathematics is a minimum requirement for those wishing to do Economics.
3	For determining the percentage of marks scored at the qualifying examination only four subjects will be counted as follows: (I) English; and (II) Three non-language subjects from the list given below (i) Mathematics (viii) History (ii) Physics (ix) Political Science (iii) Chemistry (x) Geography (iv) Biology (xi) Psychology (v) Economics (xii) Sociology (vi) Business Studies (xiii) Philosophy (vii) Accounting	The disciplines that are excluded have little or no relevance in the study of Economics.
