About the conference

The United Nations' 2030 Agenda for Sustainable Development is a call for 193 countries of the world to make sure that development is sustainable, inclusive, and holistic. The 17 Sustainable Development Goals (SDGs) and 169 targets demonstrate the scale and ambition of this new universal Agenda. They are integrated and indivisible and balance the three dimensions of sustainable development: the economic, social and environmental. The SDGs recognize trade as a means of implementation and a cross-cutting issue which can be used as a tool for meeting many targets of SDGs.

With the given economy-political agenda, this joint conference aims to explore ways of improving our understanding on the (inter)actions among firms, industries and government policies in global trading structure.
