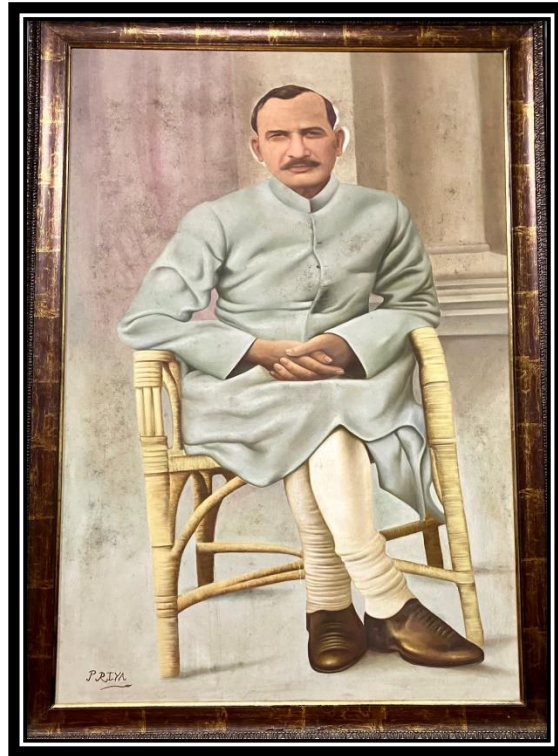

## **Sir Shri Ram** **(1884-1963)**

Sir Shri Ram, an eminent and public spirited philanthropist, an outstanding industrialist, a visionary businessman and an educationalist, was born on April 27, 1884. His parents were Shri Madan Mohan Lal and Smt. Chando Devi.

Sir Shri Ram completed his schooling in Delhi and joined Cloth Mills (DCM) in 1909 as a humble worker and went on to turn it into one of the largest business houses of India- the DCM Group.

Sir Shri Ram was an ardent advocate of education. As early as in 1921, he demanded free and compulsory education for all. During his life, his main emphasis was on vocational, technical and women's education. He conducted first experiment in vocational-oriented education to promote business education by founding the Commercial Education Trust in the year 1920. Over the next forty years the trust set up no less than seven educational institutions including the Shri Ram College of Commerce and Lady Shri Ram College, both in Delhi. The Commercial Education Trust laid the foundation of the Commercial College in 1926 which on its silver jubilee in 1951, was rechristened after the name of the founder as the Shri Ram College of Commerce, popularly known as SRCC. Over the years, SRCC has established itself as an institution having vision of fostering meaningful education in the field of business and economics across the globe.

Sir Shri Ram played an instrumental role in setting up prominent educational institutions such as Shri Ram College of Commerce and the Lady Shri Ram College. In recognition of his important contribution for the society, the British Government bestowed upon him the prestigious Knighthood in 1941.

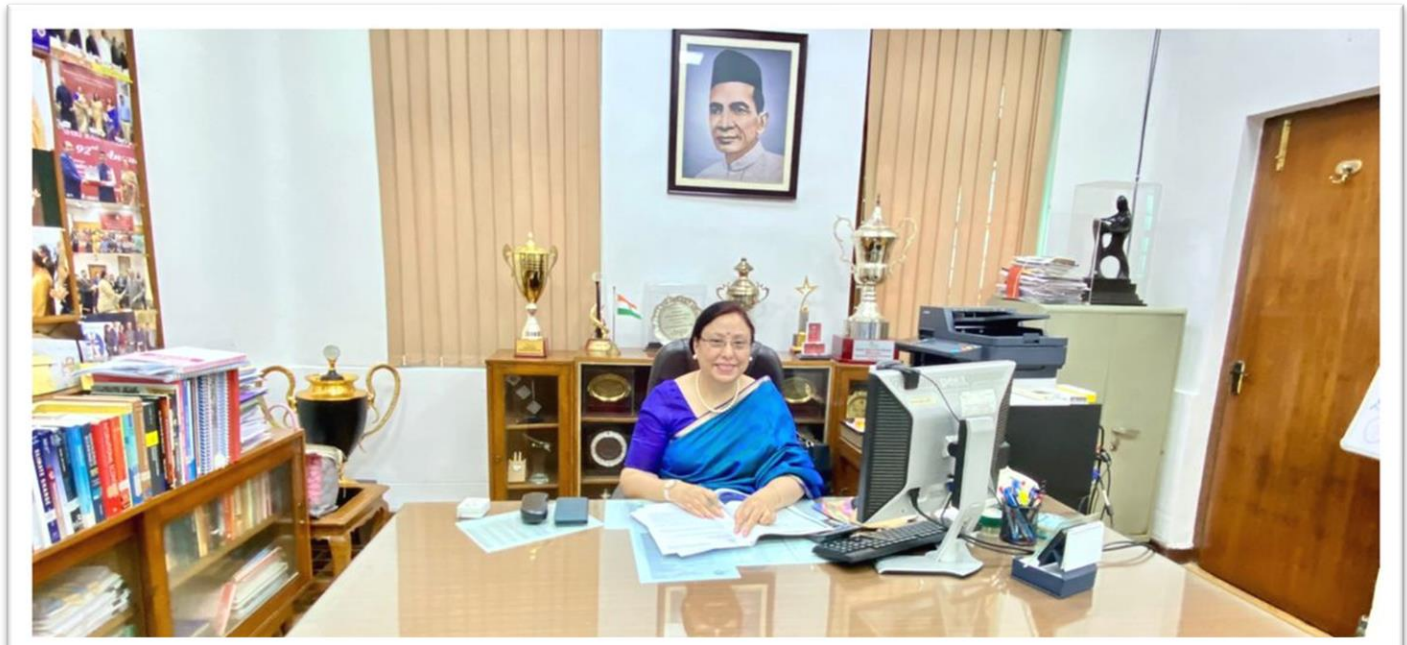

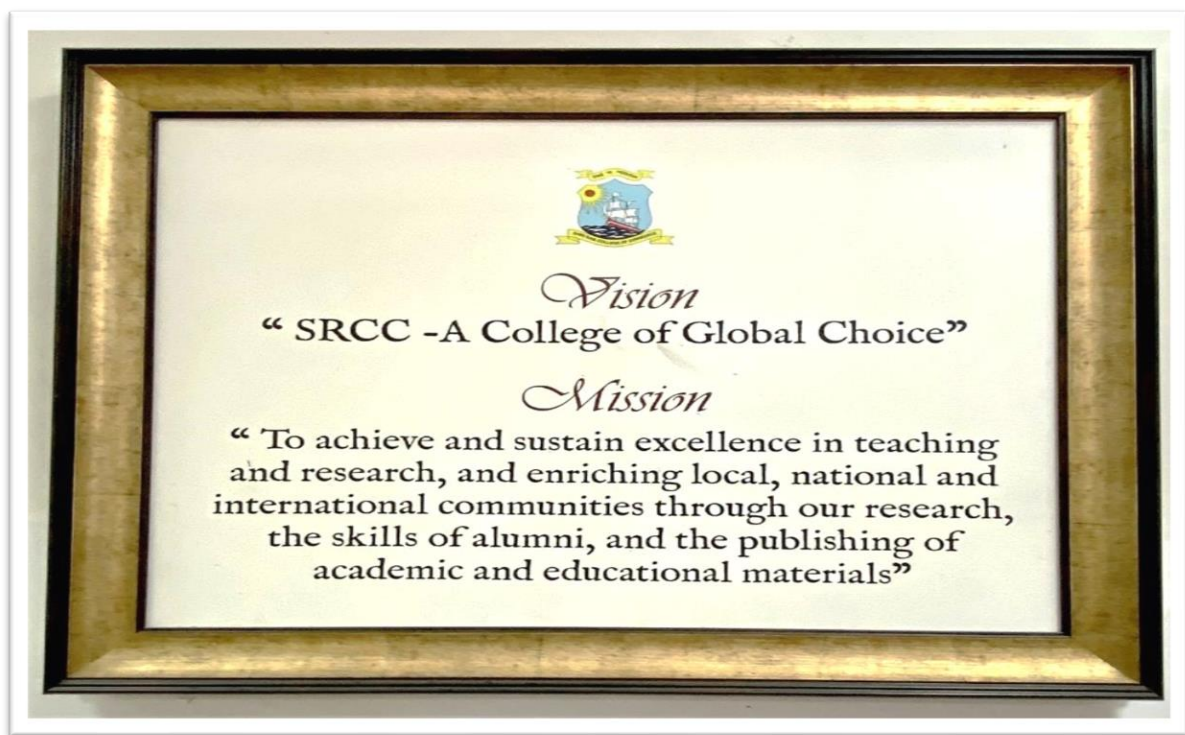

## ABOUT SHRI RAM COLLEGE OF COMMERCE



The Shri Ram College of Commerce, the first specialized college for imparting business education in the University of Delhi, was established in 1926 as the Commerce College by Sir Shri Ram at Daryaganj in the walled city of Delhi. Later, on the occasion of its Silver Jubilee in 1951, the Commerce College was rechristened as the Shri Ram College of Commerce and shifted to its present sprawling campus in the heart of the University precincts in 1954. Over the past ninety five years, the College has witnessed a phenomenal expansion from twelve students at its incipience to about three thousand students at present. Similarly, the number of teachers has also increased to about one hundred and thirty. The College runs Undergraduate and Postgraduate programs under the aegis of the University of Delhi.

The College building has been accorded the esteemed status of a '**Heritage Building**' by the Archeological Survey of India. It has fully air-conditioned class rooms, tutorial rooms, library, auditorium, seminar room and canteen. Apart from that, the college has a sprawling sports complex, hostels for girls and boys, swimming pool, gymnasium, medical support unit and a physiotherapy unit. The college campus is differently-abled friendly with ramps, lift, special washrooms and separate canteen.

Apart from academics, the College fosters an ambience for extracurricular activities for honing the soft skills of the students under the guidance of the faculty advisors. The spectrum of activities and interactions with eminent personalities from diverse fields such as politics, business, media, bureaucracy, entertainment and sports amongst

others further makes learning at SRCC a comprehensive experience.



Every year, hundreds of students find placement opportunities in various domains such as finance, banking, research and consulting amongst others in top global companies visiting the campus. We also have an increasing number of internship opportunities available to our students. The alumni of the College have brought pride to the College spreading their radiance to a multitude of disciplines.

The College actively engages and promotes stakeholders participation through appropriate feedback mechanism. 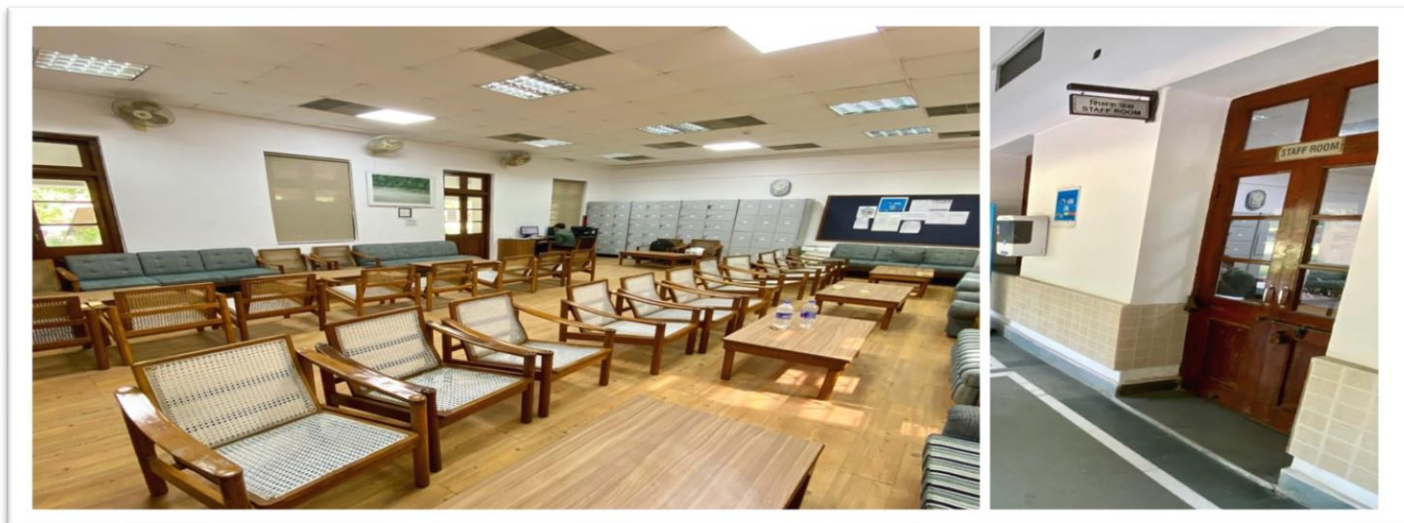

## Academic and Learning Environment at SRCC

SRCC offers a high quality of academic and learning environment in an inter-disciplinary setting as prescribed under the CBCS. The College has a good teacher-student ratio of about 1:21 with highly dedicated, enthusiastic, skilled and experienced faculty members. SRCC not only offers classroom teaching but also provides additional learning opportunities to students in number of ways.



## **Departments, Faculty Members and Teacher-in-charges**

SRCC has eight teaching departments to offer high quality teaching environment to its students. Each department is headed by a Teacher-in-Charge (TIC). TICs are appointed on rotation basis for an academic session. Students can approach respective TICs for any academic assistance in the particular academic field.

The College has highly qualified faculty members. Around sixty percent teachers of SRCC possess research degrees in the form of Ph.D. and M.Phil. from various top institutions across India. More than fifty percent teachers have experience of more than ten years. Each faculty member has expertise in his/her subject of specialization. Apart from teaching , they are actively engaged in research , dissemination of knowledge , development of new curriculum, undertaking research projects , conducting workshops , and participating in seminars , symposia and conferences at National and International levels. Many of them also have to their credit publications of books and research articles in reputed journals.

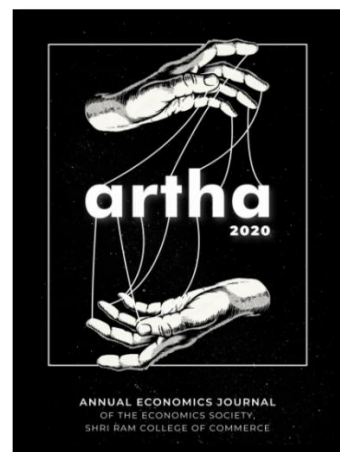
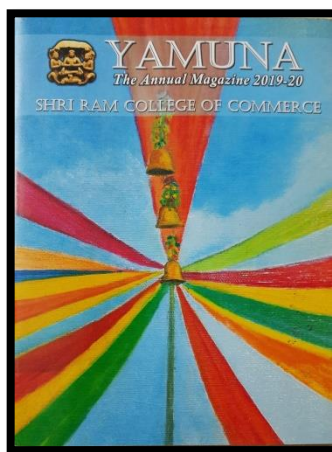
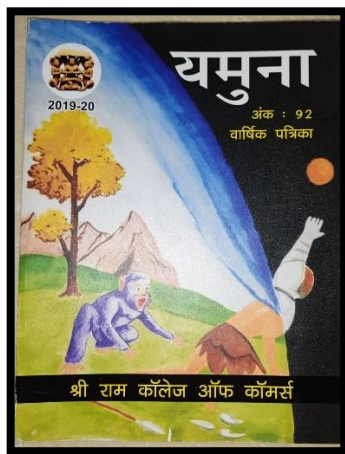
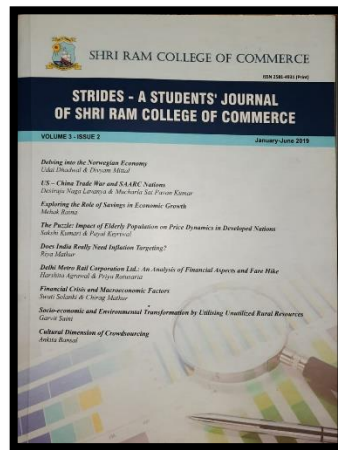
### **Other Publications**

It's normally released by the chief guest on the Annual Day.



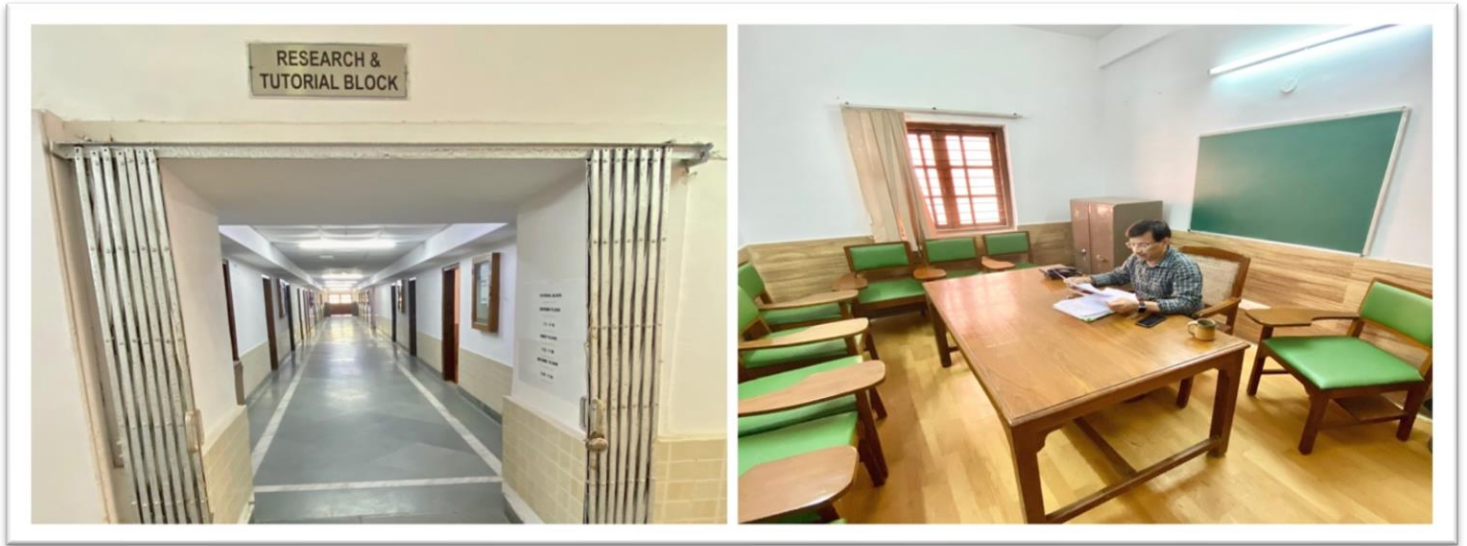


## **INFRASTRUCTURE AT SRCC**

### **Classrooms and Tutorial Block**

SRCC has centrally air-conditioned class rooms and equipped with not only anthropometrically compatible teak wood furniture but also modern teaching facilities such as Wi-Fi, LCD projectors with screens. Apart from class rooms, the College has a three-storey Tutorial Block with fully air-conditioned tutorial rooms which facilitates personalized student-teacher interaction and customized teaching learning environment.





## Library

The College is privileged with a fully air-conditioned and fully automated library which caters to the needs of about three thousand members which include not only undergraduate and postgraduate students but also the teaching and non-teaching staff of the College. The library uses **Radio Frequency Identification (RFID) technology** and database management software LIBSYS version 7 to provide seamless access to its readers.



The library is a knowledge hub with a rich and ever-growing collection of over 75000 books with latest publications in the field of Commerce, Management, Statistics, Mathematics, Economics, Humanities, Social Science and literature to provide a wide range of academic resources to students and faculty members. Apart from books the library also provides access to journals, reports, and statistical packages and plagiarism check software.

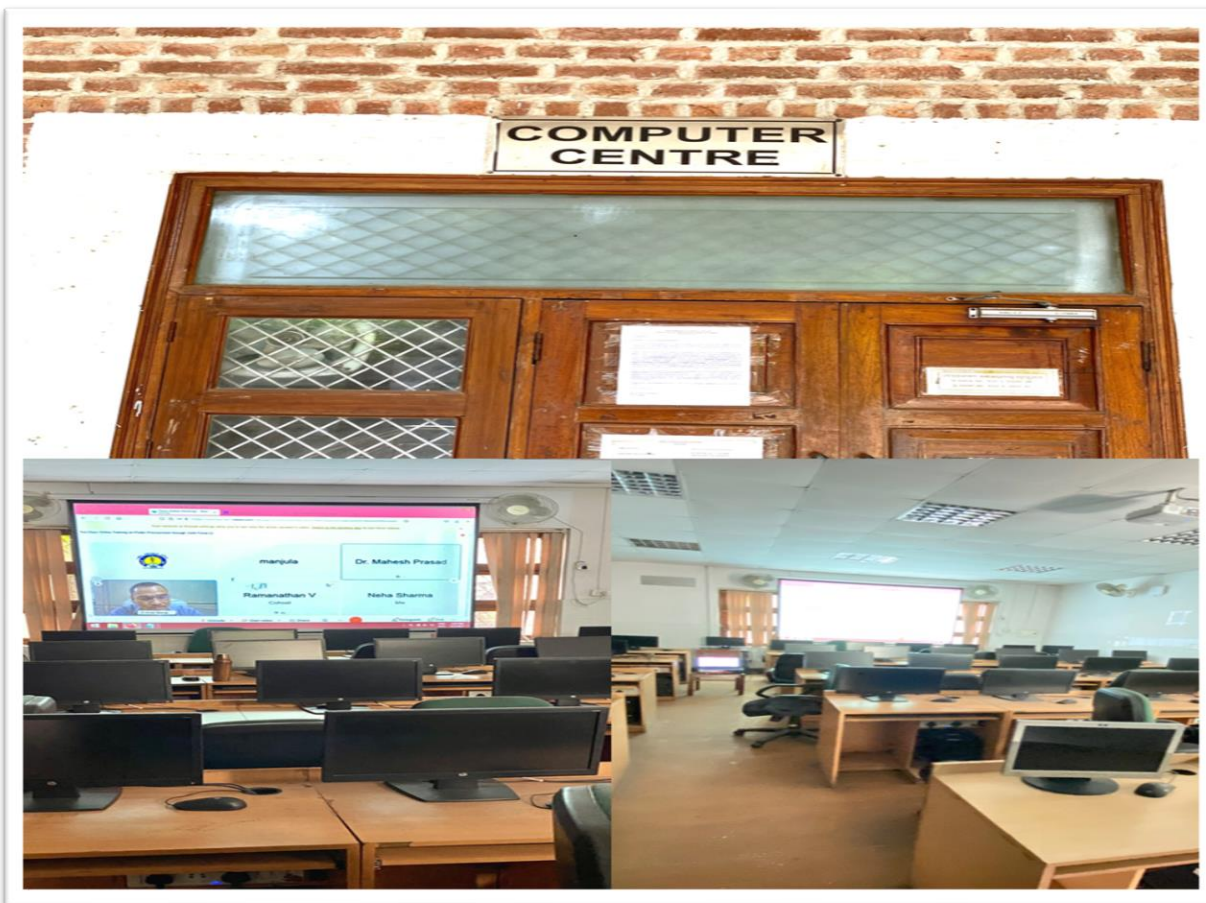
It has two large reading halls accommodating around three hundred students. It is well equipped with all the modern facilities and resources (print and electronic) in the form of CD-ROMs, DVD-ROM, video cassettes etc. It has also developed a full-fledged digital library. The library collection can be searched in **OPAC (Online Public Access Catalogue)**. It also permits access to the electronic resources provided by DULS (Delhi University Library System) and also provides remote access to e-publications through **DELNET**. There is a separate and dedicated internet service area installed with thirty computers to facilitate the members to access internet and online resources. The library has subscribed to various newspapers and about eighty national and international journals for its readers. The library has also adopted the theme of cashless and is progressing towards paperless environment.

The library has a dedicated unit which is fully equipped with modern tools and electronic apparatus to facilitate learning for the visually challenged readers.

## Computer Centre

The College has three computer labs having a total of ninety computers equipped with updated software and hardware along with high-speed internet connectivity and uninterrupted power backup. The computer labs are also installed

with projectors as a teaching aid. In addition, the computer centre is also available to students for accessing internet, practicing and preparing their projects.



### **Seminar Room**

A state-of-the-art seminar room was constructed in the 2000-01 on the occasion of the Platinum Jubilee of the College. It is fully air-conditioned with LCD projection facilities with seating capacity of about 100 people.

### **Auditorium**

The College has an air-conditioned Auditorium with a seating capacity of over 750 persons. The auditorium is equipped with lighting and sound systems. All important functions of the college are organized in the auditorium, Currently, Auditorium is under renovation.



## Sports Complex

The College is proud to have a centrally air-conditioned gigantic sports complex built by the Government of India in the year 2010. The complex stands parallel to any other world class structure, equipped with all amenities and facilities available for the sports players. Apart from a multipurpose hall and an extensive sports ground, the sports complex includes changing rooms, a physiotherapy unit and gymnasium. The multipurpose hall comprises of a wooden floor catering to the sports like basketball, badminton, table tennis, yoga, chess etc. It has a seating capacity of about 1200 spectators. The Sports Complex includes the following infrastructure:-

## **Multipurpose Hall**

The hall comprises of a wooden floor of size 33m x 33m. It has a seating capacity of more than 1200 spectators. It includes changing rooms and fitness centre. The multipurpose hall caters to the following sports:

- Basketball
- Badminton
- Table Tennis

## **Fitness Centre**

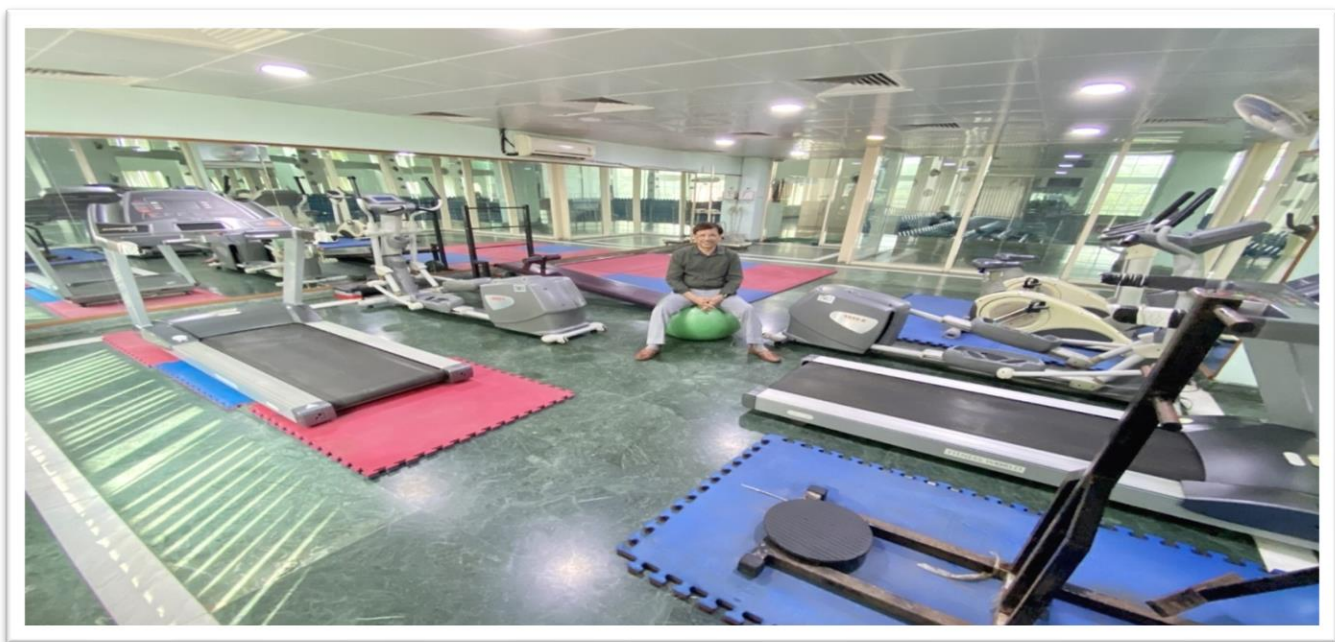


The College maintains its own fitness centre. It is located inside the multipurpose hall in the sports complex possessing equipment for full bodyweight exercises, gym ball exercises/ Swiss ball exercises, resistance band exercises, resistance machine exercise and stretching exercises. The centre also holds classes for kickboxing, yoga and aerobics.

- Weight Training Section: It comprises of Olympic Weightlifting weights, Exercise stations, Swiss balls etc.
- Cardio Section: It consists of Treadmills, Elliptical trainer, Cycles etc.

## **Physiotherapy Unit**

Physiotherapy services for staff and students along with other basic medical facilities are available in the College. The physiotherapy section has Electrotherapy room and Exercise Therapy Room. The Electrotherapy room is equipped with all the basic Physiotherapy Modalities, namely, Interferential Therapy (IFT), Transcutaneous electrical nerve stimulation (TENS), Muscle Stimulator, Short Wave Diathermy (SWD), Traction Machine, Wax Bath therapy & Hydro Collator meant for pain, relief and relaxation. Exercise Room has the basic exercise equipments, namely, Shoulder Wheel, Wrist Exerciser, Ankle Exerciser and Foot Exerciser) along with some equipment especially for sports students that include resistance bands and loops, Swiss Balls, Foam Rollers, Bosu Balls, Medicine Balls and Weigh Cuffs. There is also RIP-60 trainer (supervision trainer) for rehabilitation and training purposes.

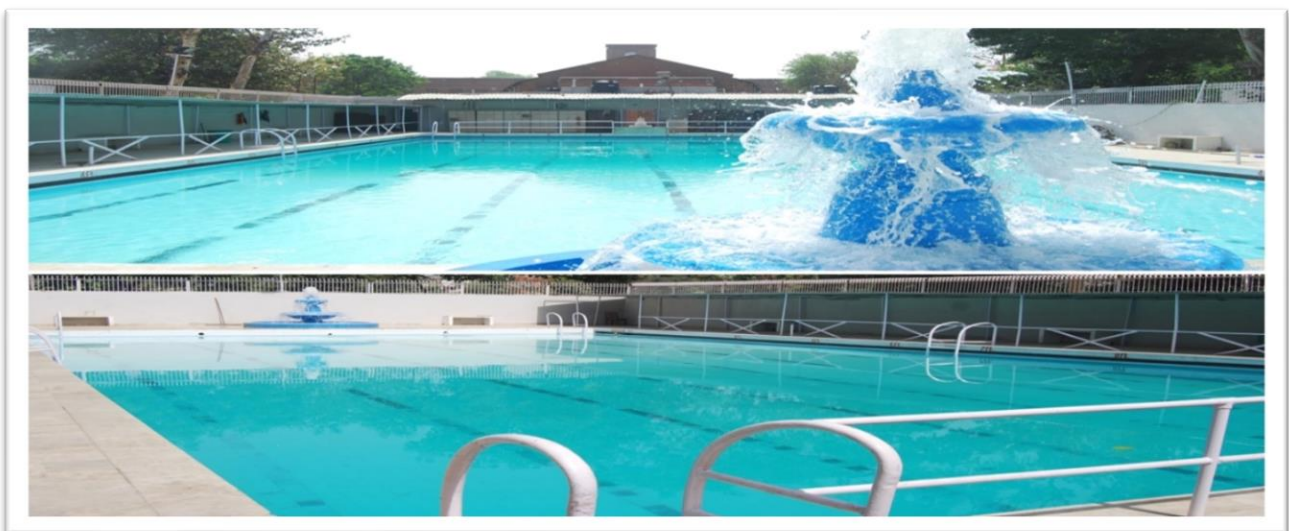
## **Playground**

The College has an extensive lush green outfield that facilitates sports like hockey, football, netball, baseball, softball, handball and athletics.



## **Swimming Pool**

SRCC is one of the few Colleges in the University of Delhi to have a swimming pool facility. The swimming pool opens during summer season only. The swimming pool is properly maintained and coach facility is also provided to newcomers.



## **Hostel Accommodation for Girls and Boys**

The College has limited accommodation for boys and girls in two separate hostels in the College Campus itself (145 for boys and 53 for girls). Their respective messes are run by Hostellers on 'No Profit No Loss' basis. Both hostels are equipped with Wi-Fi and hostel administration tries to provide requisite facilities of international standards. A newly constructed 100 bedded girls hostel is about to be operational in near future.

Students desirous of hostel accommodation should refer to the relevant girls / boys hostel prospectus available in the college/hostel office and apply in the prescribed form at the time of admission. It should be noted that hostel accommodation is subject to the availability of seats and admission to the college doesn't imply admission to the hostel.



### **SRCC Café**

The college has a fully air-conditioned Café which is popular meeting place for the students. It provides refreshing and delicious snacks, meals and beverages. There is a separate Café for differently-abled students.



### Cooperative Store

The College has an in-house Bookshop. It provides books, reference materials and stationery products to the students. (Facility is available on payment basis)

### Photostat Shop

There is a photocopier in the campus. The students can avail the facility of photocopy, printing as well as compilation of study material. (Facility is available on payment basis)



## Bank

The College houses a branch of State Bank of India (SBI). Students can open their account as well as take advantage of other banking facilities from the SBI branch.



## Parking Facility

The College has a parking area for its staff and students. Entry to parking area is restricted to availability of space. The parking area is under CCTV surveillance and a guard has been deputed to facilitate secured parking.



## Basic Health Care Unit

A full - time nurse is appointed for this purpose. Further, the consultation services of a general physician and an orthopedist are also available on specific day. The College maintains a Basic Health Care Unit wherein basic medical support is provided to the staff and students.

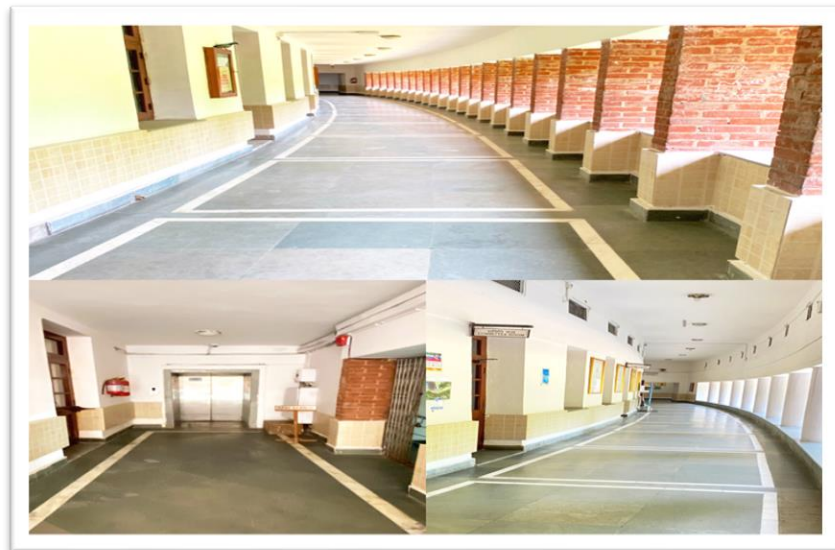


## Wi-Fi Enabled Campus

The College has a Wi-Fi enabled campus. The College server is connected with the University's main campus server. Students can obtain Login ID and Password from the Computer Centre of the College.

## Lift

The College has a lift facility and a dedicated lift operator to aid differently-abled students in particular.



## ENABLING ENVIRONMENT AT SRCC

### Resources for Differently-abled Students

The College devotes special attention to cater the needs of differently-abled persons. Under the SRCC Enabling Unit, the College has developed a unique resource centre for visually impaired students. The Resource Centre consists of state of the art technology which exponentially empowers the differently-abled students to enhance their learning abilities with screen reading software like **JAWA, Super OVA and Kurzweil**. There is a range of text magnifiers and portable **OCR (Optical Character Recognition)** readers to read hard text instantly. Further, a talking notice-board with a digital-audio database for all the notices is set up in the resource centre. Apart from this, the entire campus area is connected with a network of ramps and an elevator to facilitate smooth movement of physically challenged persons. The College also has two electronic wheel chairs for the aid of students with locomotive disabilities. Separate canteen has been set-up for facilitating differently-abled students.



### **Counsellor Room**

SRCC has collaborated with the team of YourDOST, an online counselling and emotional support platform, to address mental health of students. YourDOST anonymously connects you with the right expert from their panel consisting of psychologists, psychotherapists, counsellors, life coaches and career coaches, who understand you and guide you through completely confidential individual sessions. During the Covid-19 pandemic, the mental health of the people got adversely affected and SRCC extended counselling service online for its students and teachers 24 x 7. On Campus the counsellor room is located in the Tutorial Block and is accessible to all who would want someone to talk to, about anything, without the fear of judgement.

### **Sanitation Park**

In pursuit of its commitment to environment protection, the Shri Ram College of Commerce initiated a Solid Waste Management (SWM) Project in order to control, reduce, recycle and dispose of solid waste of the college. It entered into a yearlong collaboration with the Feedback Foundation Trust to setup the project and to develop a mechanism that is sustainable in the long run too. To further the objectives of the SWM project, a sanitation park has been created for generation of good amount of compost ready to be used in the college gardens as manure.

### **Botanical Garden**



The Botanical Garden near the Principal bungalow is an expanse of lush green garden packed with a plethora of most exclusive plants and trees. The garden is further used to conduct educational programs to increase awareness among students. At the park's edge, one can relax on a bench and enjoy the serenity.



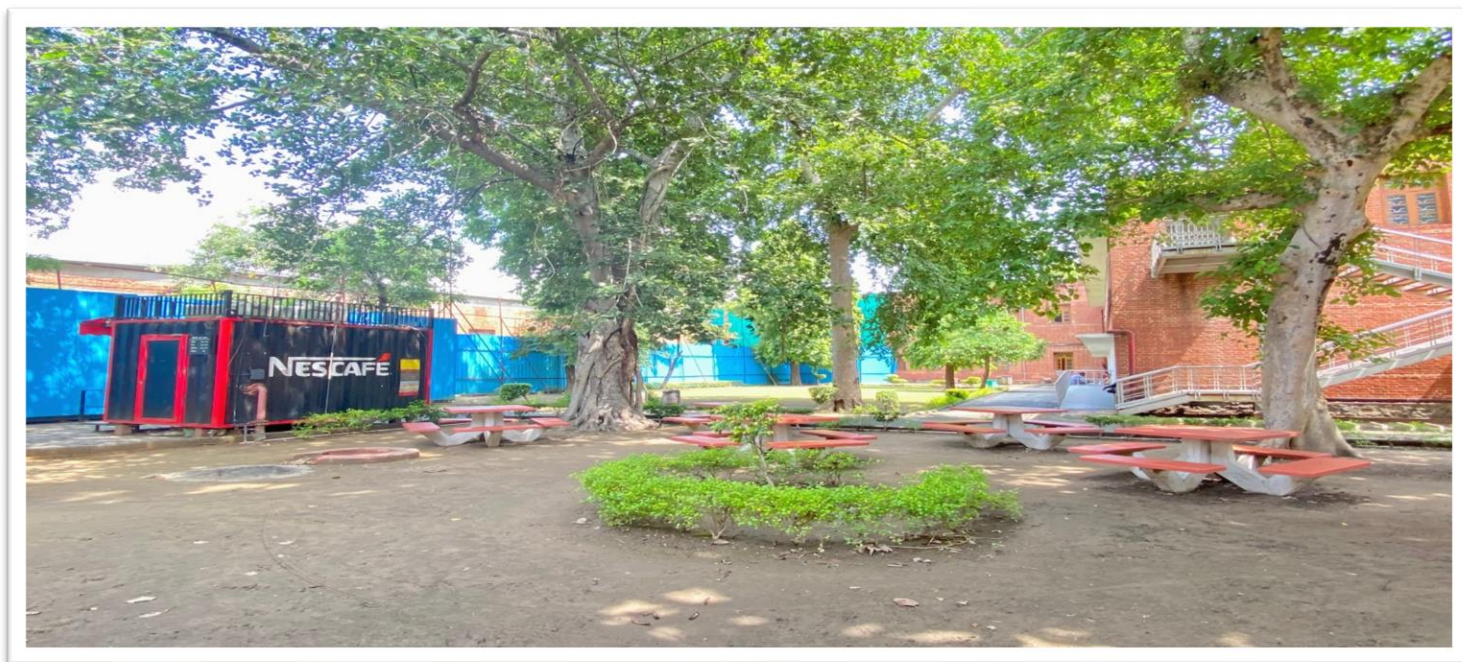
### **NADEP Composting Pits and Separate Bio and Non-Bio Waste Bins**

Emphasising on the importance of cleanliness and the important goal of sustainability, the college endorses the Two-Bin Waste Segregation system and therefore has bins at multiple locations, allowing for easier disposal of waste and inculcating a habit of effective waste management by segregation. Three NADEP composting pits had also been constructed in the park where composting process is fully operational. A bamboo hut had been erected in the Campus which houses two NADEP composting pits, where composting process is fully operational, and one garden waste

shredder. Shredding of leaves is being done as per the capacity of the composting pits and sufficient compost is generated for college gardens. Separate dustbins have been placed in the campus for segregation of waste at the source itself.

### **Nescafé**

Expanding on the multiple menu options available to the students, a refreshing touch of modernity comes from the recently installed Nescafe outlet. Catering to the ever changing palates of Gen-Z, the outlet boasts of unparalleled variety in snacks, confectioneries and drinks.



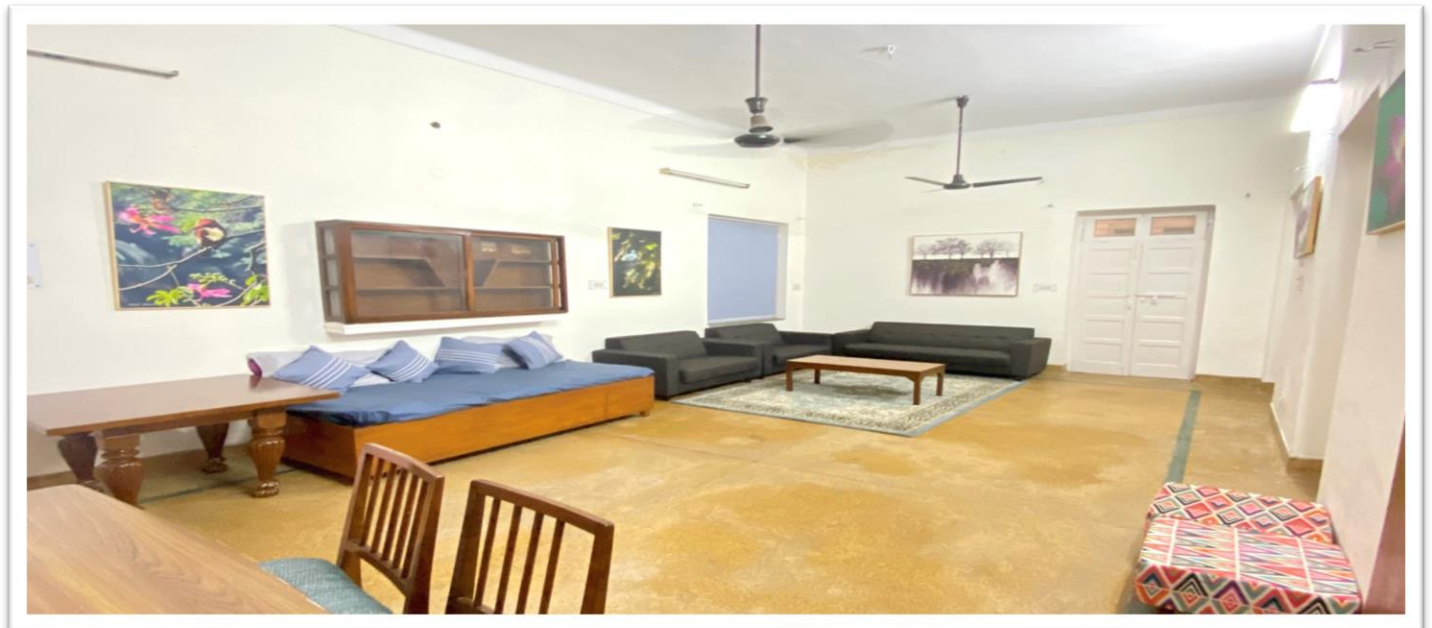
### **Differently-abled Friendly Canteen**

In line with the motive of making the campus more inclusive, the College has a canteen for differently-abled students. Located just opposite to the main canteen, the infrastructure features a ramp to allow easier ascent to the canteen alongside refreshing snacks.



## Girls' Common Room

Shri Ram College of Commerce respects gender diversity and promotes an inclusive environment for the female students. The College has created a Girls' Common Room (GCR) equipped with sanitary vending machine in recognition of their need for personal space. The GCR is strategically located at the Principal Bungalow to maintain the privacy of the girl students of the college. It has comfortable seating space with sofa sets, dining table and a bed along with beautiful photographs by Ashok Dilwali to add to the aesthetic appeal. The women washrooms in the college are equipped with a vending machine for sanitary pads to ensure availability as and when required.



## Crèche

In order to support the parenting needs of the college staff, Shri Ram College of Commerce provides Crèche facility to its employees. It has created a safe and secure place where the employee kids can stay while the staff is at work. A spacious room has been dedicated for the Crèche facility in the Principal Bungalow in order to support staff at the workplace. The Crèche has been designed in order to accommodate the kids of varying age groups and provides for various learning tools like books, wall stickers and toys for cognitive stimulation. It also has a play area, a crib and a bed where the kids can rest, if required.



## Green Ride Public Bicycle Sharing Services

SRCC launched the cycle stand, a green transport and commuting initiative, in collaboration with Delhi Cycle Private Limited (DCPL) and Tech Mahindra Foundation. SRCC actively encourages the use of non-polluting transport mediums to care for the environment in our own small ways. We believe that the service will promote greater use of an economical and healthy habit amongst the community while also reducing our impact on the environment.



## **Car Pools**

In order to reduce pollution from the transport of the members, car-pooling is encouraged in the College. A dedicated parking space has been reserved for carpools in the college parking lot.

## **Solar Panels**

The College has installed a few solar panels for energy conservation. The curvilinear design of the building as well as the installation of open-nets according to architectural best practices reduces the emphasis on artificial light. The College is also transitioning to LED lights to save energy usage in the premise. Further, the College has a systematic monitoring mechanism to ensure the lights and fans of rooms are closed when not in use.

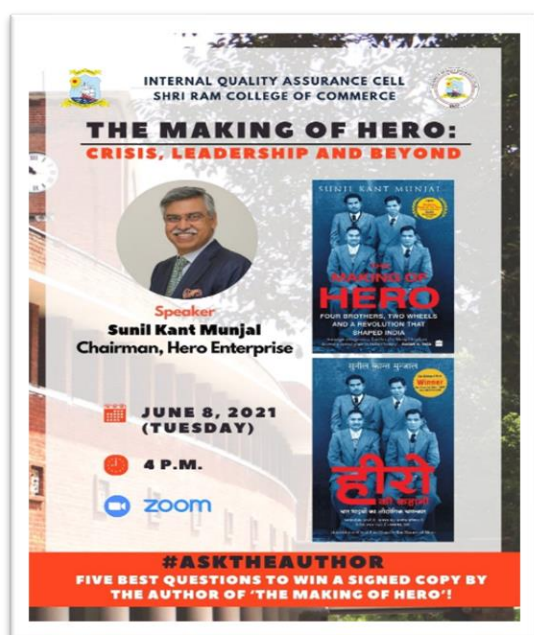
### **Shri Ram Centre for Personal Growth**

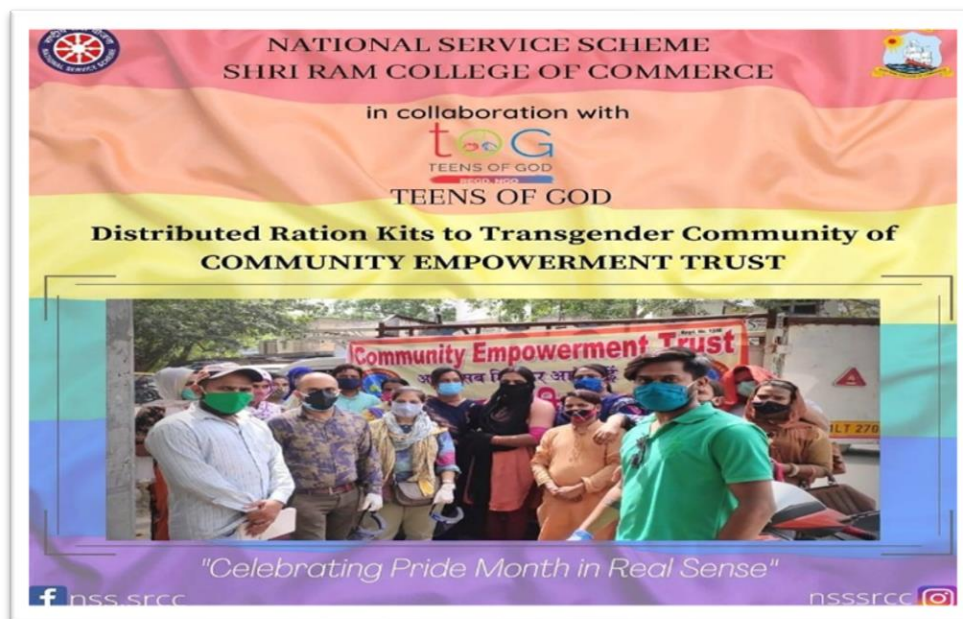

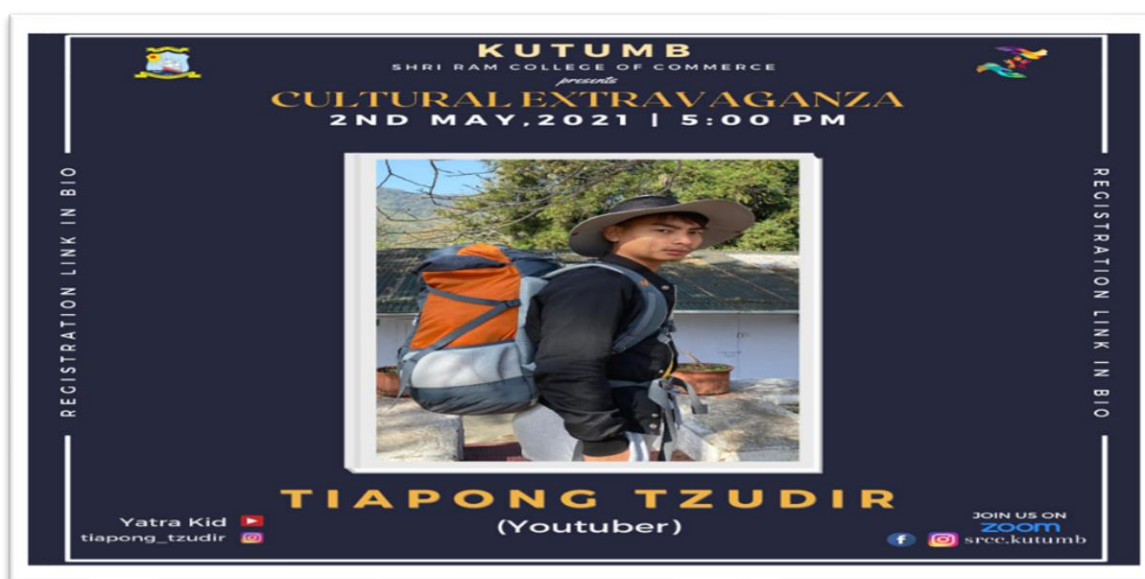
## National Service Scheme (NSS)

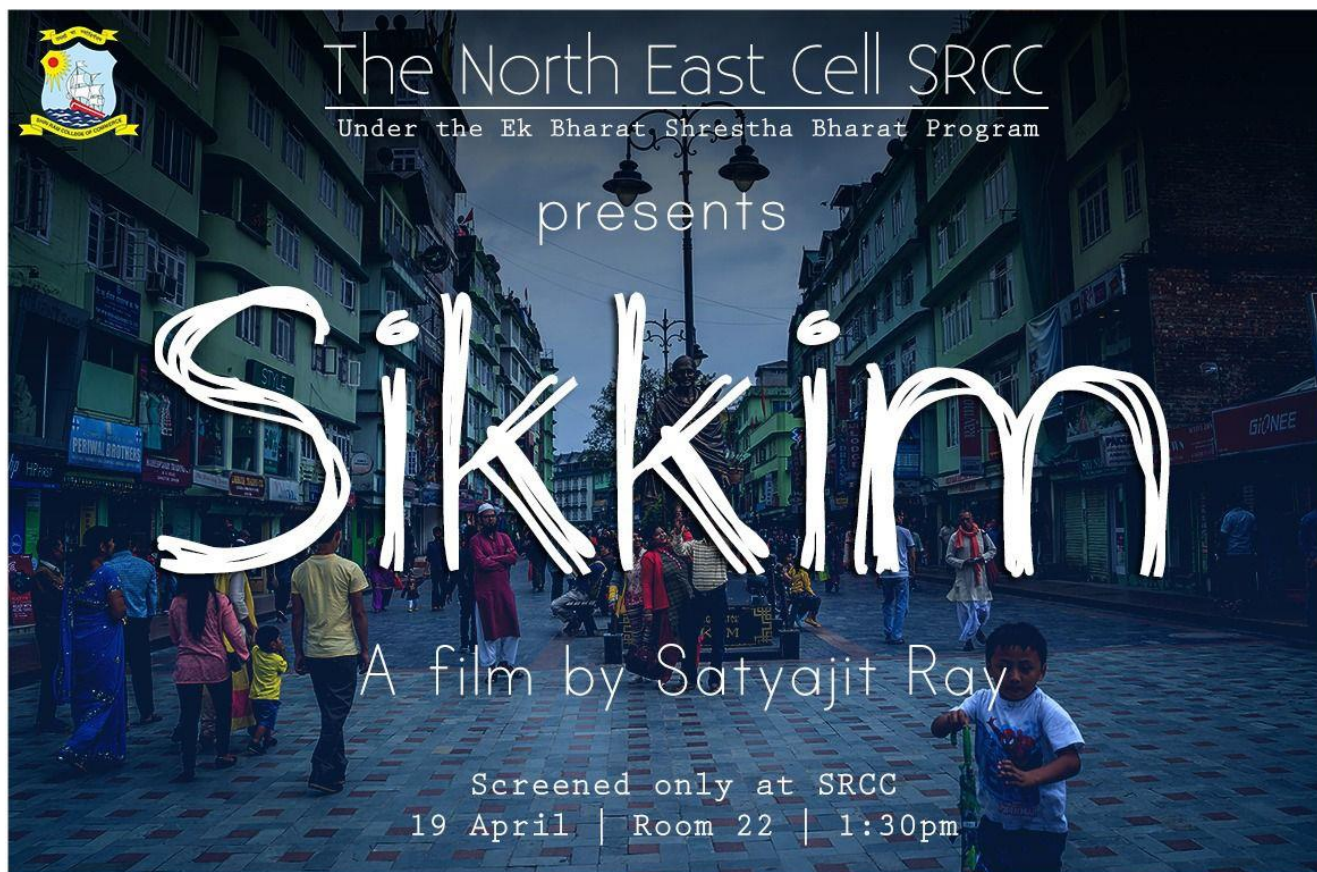


### **The Shri Ram College of Commerce - North East Cell (SRCC-NEC)**

## **Cultural Council**

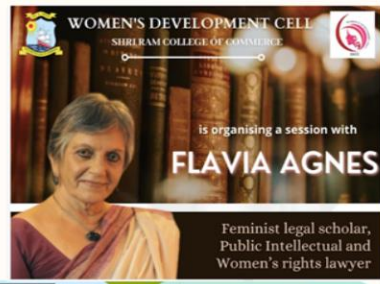

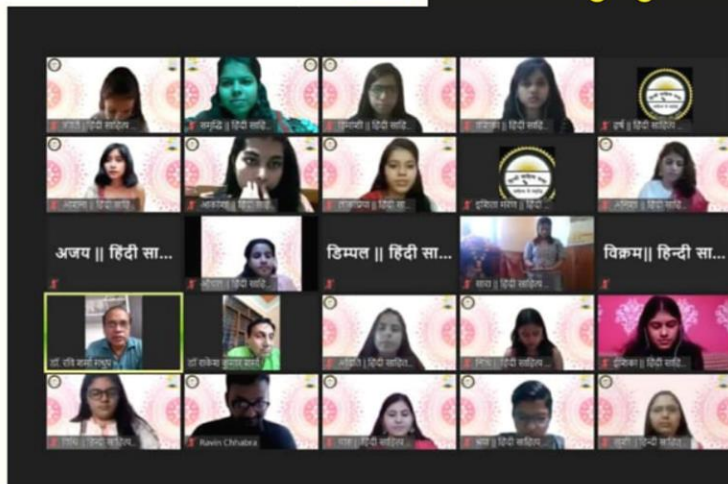

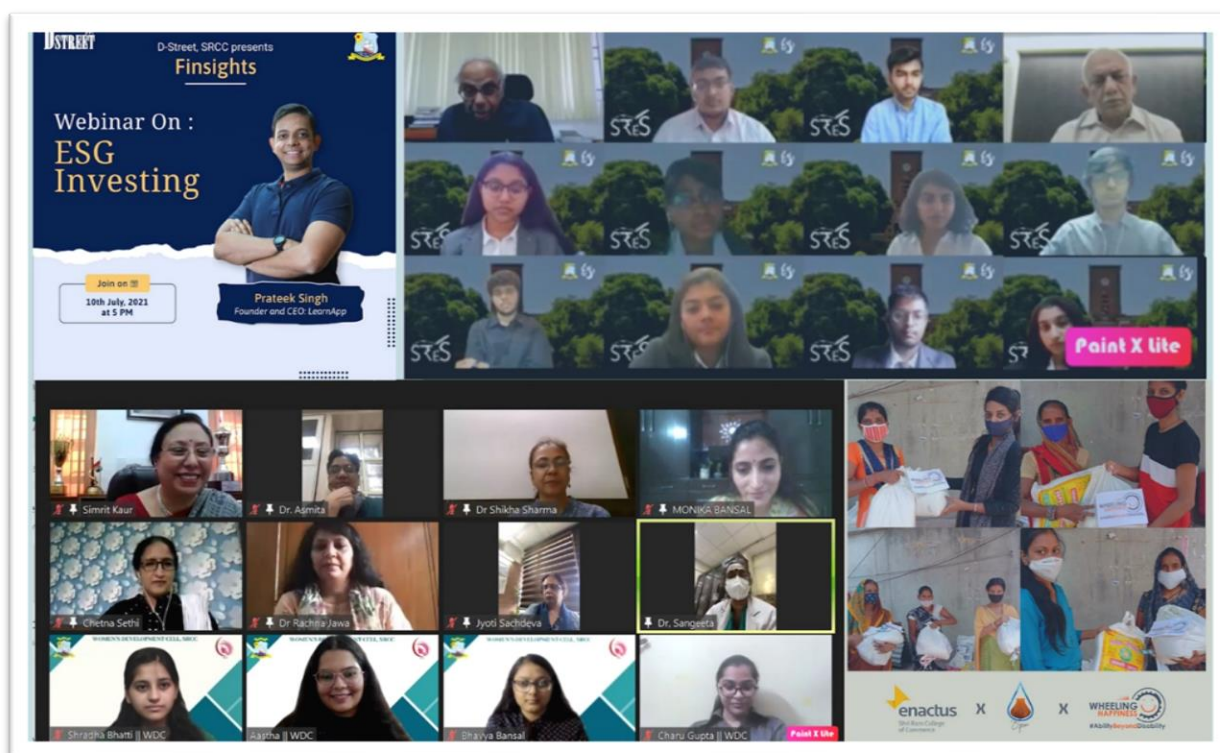

The panelist included eminent personalities including Ambassadors of various countries. ### Important Guidelines for Admissions to Undergraduate Courses 2021-22

College follows the admission guidelines, schedule and criteria as specified in the Bulletin of Information for Admission to Undergraduate Programs (2021-2022) of the University of Delhi. Admissions to B.A.(Hons.) Economics and B. Com (Hons.) Courses of the University of Delhi are merit based (that is, based on marks

scored in Class XII Board/qualifying examinations).

- All candidates must register through the University of Delhi online admissions portal [www.admission.uod.ac.in](http://www.admission.uod.ac.in).
- All undergraduate admissions for 2021-2022 will be administered only through Delhi University Portal.
- There is no offline admission for any candidate.
- Only eligible Candidates who have registered online through the university portal can be considered for admission.
- Candidates will be required to appear in person for verification of their original documents, as and when notified by the University/College.
- All admission procedures are to be completed by the Candidate using the unique Login Id they create on the Delhi University Undergraduate Admissions Portal.

## **Eligibility Criteria for Admissions to B.Com.(Hons.) and B.A.(Hons.) Economics**

- ❖ The candidate must be a citizen of India.
- ❖ Candidates seeking admission under the Foreign Students' category to apply separately on Foreign Students' Registry website, <http://fsr.du.ac.in>.
- ❖ The Candidate should have passed the Class XII examination of any Board/ University examination in India or in any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- ❖ The Candidate should have “passed” individually in each subject required (including practicals if any) for calculating merit and eligibility to the program they seek admission in.
- ❖ Candidates with gap year(s) will not be at any disadvantage for the purpose of admission to undergraduate courses.

### **The following categories are designated "Supernumerary":**

1. PwBD (Persons with Benchmark Disabilities);

2. CW (Children/Widows of Personnel of the Armed Forces including Para-Military);
3. KM (Kashmiri Migrants);
4. Prime Minister's special scholarship for Jammu and Kashmir;
5. SS (Nominated Sikkimese Students);
6. WQ (Ward Quota);
7. ECA (Extra Curricular Activities);
8. Sports.

### **Relaxations in Course-specific Eligibility Criteria**

- ❖ To determine their eligibility and merit, applicants from the **SC/ST categories** shall be given a relaxation to the extent of 5% in the respective eligibility criteria and merit for admission prescribed for applicants from the UR category. If, after giving 5% relaxation, these reserved seats still remain vacant. Further relaxation would be given to the extent required in order to fill all the reserved seats in the course concerned. Eligibility in such cases is the pass percentage.
- ❖ To determine the eligibility and merit, applicants from the **OBC category** shall be given a relaxation in the respective eligibility in the qualifying examination to the extent of 10% of the eligibility marks prescribed for applicants from the UR Category. For example, if the minimum eligibility for admission to a course is 40% for the UR Category applicants, the minimum eligibility for the OBC category will be 36% (i.e. 40% minus 10% of 40%).
- ❖ Applicants from the **PwBD category** shall be given a relaxation in the respective eligibility for the course concerned in the qualifying examination to the extent of 5%. For example, if the minimum eligibility for admission to a course is 40% for the UR Category applicants, the minimum eligibility for the PwBD category will be 38% (i.e. 40% minus 5% of 40%).
- ❖ Applicants from the **CW category** shall be given a relaxation of 5% in the respective eligibility for the course concerned in the qualifying examination. For example, if the minimum eligibility for admission to a course is 40% for the UR Category applicants, the minimum eligibility for the CW category will be 38% (i.e. 40% minus 5% of 40%).
- ❖ Eligibility Criteria for merit-based admissions under the **EWS category** shall be identical to that of UR category.

### **Computing Merit Score: General Guidelines**

1. All academic subjects may be treated as "elective." The subjects eligible for computation (subject to course-specific criteria) are listed below in List A and List B.
2. The University may define any other relevant subject(s) as academic/elective for a particular course.
3. Merit is calculated through course-specific combinations of marks obtained in the qualifying examination in the "Best Four" subjects for admission to B.A. (Hons.) / B.Com. (Hons.) courses.

### **Merit-Based Admission to B.Com.(Hons.)/ B.A. (Hons.) Economics**

The eligibility criteria and combination of subjects for calculation of merit for Admission to B.Com.(Hons.) and B.A.(Hons.) Economics are given in the Bulletin of Information for Admission to Undergraduate Programs (2021-2022) of the University of Delhi and are specified separately as follows:

## Special Instructions for Candidates from Boards other than CBSE

1. If a paper's title does not match with what is specified in List A and List B above, it is mandatory for the Candidate to provide a content equivalence certificate from the Principal/Head of the Institution last attended, certifying that the paper's content is equivalent to NCERT Class XII syllabus for that paper. This equivalence certificate must be accompanied by a copy of the syllabus of the paper attested by the Principal/Head of the Institution. However, the University of Delhi's decision on the matter will be final and binding.
2. If the Candidate has studied "Botany" and "Zoology" separately, the total of marks in both these papers must be entered in the respective fields for theory and practicals under the heading "Biology" in the field provided in your admission form
3. If the Candidate's mark sheet contains both Class XI and XII marks, the applicant must enter **only the Class XII marks** in the respective fields provided in the admission forms.
4. Candidates should have passed theory and practical separately. Any paper with both theory and practical component will be considered only in the ratio **70 (theory): 30 (practical)** if the theory component of the paper is less than 70%. The applicant should separately fill into the Admission Form the marks obtained and the maximum marks for theory and practical each, and the totals, as per their mark sheet. In case the **theory/practical breakup is not specified**, the Candidate will be required to enter only their total marks in the first field ("Theory") for that paper in the online Registration form. (See Example 1 for sample calculations)
5. "Internal Assessment" marks, if any, mentioned in the mark sheet will not be used for any calculations. (See Example 2 for sample calculations)
6. Any discrepancy in the entry of marks pertaining to theory, practicals or total will be the sole responsibility of the Candidate. Candidates are advised to exercise utmost care in filling up the form as errors in entry may lead to summarily rejection of the form

### Reservations for SC/ST/OBC/EWS/PwBD/CW/KM

The college follows the admission guidelines, criteria and schedule as notified by the University of Delhi. All candidates, irrespective of their categories, must be registered on the centralized admission portal of the University of Delhi for admission to the courses available at the college.

College will announce cut-offs for candidates of all the main categories (UR/EWS/OBC/SC/ST/PwBD) for B.Com.(Hons.) and B.A.(Hons.) Economics separately as per the admission and cut off schedule of the University of Delhi for Undergraduate admissions for 2021-2022.

The merit list for the unreserved category (UR) seats will comprise all the applicants in order of merit. No one will be excluded from the same. In other words, the merit list will also include SC/ST/OBC/EWS applicants, irrespective of category, if they meet the criterion of merit for UR category. No applicant can be excluded from the UR category merit list just because the applicant belongs to or has applied under SC/ST/OBC/EWS category. Such an applicant is entitled to be considered under the UR category, as well as under the reserved category. Admission to UR category seats will be strictly in order of merit without excluding SC/ST/OBC/EWS applicants.

Applicants seeking admission under SC/ST/OBC/EWS category will have to produce certificates for verification in their own names.

### Reservation of Seats for SC/ST

- 22.5% of the total numbers of seats is reserved for applicants belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary).

The following are empowered to issue the requisite SC/ST certificate:

District Magistrate/ Additional District Magistrate/ Collector/Deputy Commissioner/Addl. Deputy Commissioner/Deputy Collector/1st class Stipendiary Magistrate/City Magistrate/Sub -Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner. Chief Presidency Magistrate/ Addl. Chief Presidency Magistrate/ Presidency Magistrate. Revenue Officer not below the rank of Tehsildar .Sub-Divisional Officer of the area where the Applicant and/or his

family normally resides. Administrator/Secretary to the Administrator/ Development Officer (Lakshadweep Islands).

**Note:**

1. The applicant must note that the SC/ST Certificate from any other person/ authority shall not be accepted in any case.
2. If the applicant happens to belong to SC or ST, applicant's caste/ tribe must be listed in the appropriate Govt. of India Schedule. The Caste Certificate should clearly state : (a) Name of his/her caste/tribe (b) whether applicant belongs to SC or ST (c) District and the State or Union Territory of applicant's usual place of residence, and (d) the appropriate Govt. of India Schedule under which his/ her caste/ tribe is approved as SC or ST.
3. If the Candidate does not have their SC or ST caste/tribe certificate at the time of registration/applying, they may upload the acknowledgement slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the Candidate will have to produce the valid original SC or ST caste/tribe certificate. However, if an SC/ST Applicant seeks admission under some other category (for example: PwBD/Employee Ward, etc.) the applicant should satisfy the minimum eligibility requirement for that particular category.

**SC/ST applicants who get admission under open merit (unreserved) shall not be included in the reserved quota, i.e. 22.5% (15% for SC and 7.5% for ST).**

### **Reservation of seats for OBC (Non Creamy Layer, Central List)**

- 27% seats will be reserved for the applicants belonging to **Other Backward Classes (OBC)** (non-creamy layer, central list).
- At the time of giving admission to an OBC applicant, the College will ensure that **the caste is included in the Central List of OBC** (the OBC status is to be determined on the basis of the Central (Govt. of India). List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website [http://ncbc.nic.in/backward\\_classes/index.html](http://ncbc.nic.in/backward_classes/index.html).)
- The certificate **must mention non-creamy layer status** of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).
- The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'non-creamy layer' status of the applicants as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res-I) dated 31st March 2016). The validity of the Non-Creamy Layer certificate shall be for the **financial year 2021-**

**2022 (for Assessment year ending on March 31, 2021), issued on or after 31st March, 2021.**

- If the applicant does not have the OBC non-creamy layer certificate of the latest financial year 2021-2022 at the time of registration, the applicant may upload the **previously issued (older) OBC non-creamy layer certificate or the acknowledgement slip of OBC non-creamy layer certificate application**. However, at the time of admission, the applicant must produce the recent financial year's (2021-22) OBC non-creamy layer certificate, issued by the same competent authority. This additional certificate must have reference of the applicant's already issued original caste certificate.

### **Reservation policy for EWS**

- As per the University of Delhi notifications (Reference No. Aca.I/Reservation of EWSs/2019/63 Dated 28th March 2019 and Reference No. Aca.I/Reservation of EWSs/2019/101 Dated 15th May 2019), regarding the reservation for **Economically Weaker Sections (EWSs) Category**, the University Departments/Centres/Colleges have reserved 10% seats for admission for the same in the Academic Year 2021-22. The eligibility of such applicants will be decided on the basis of fulfilling criteria prescribed in the above notifications, and subject to submission of documents, issued by the competent authority, in the format provided in Appendix V of the Bulletin of Information for Admission to Undergraduate Programs (2021-22) of University of Delhi.

1. No further extension/relaxation for submitting the required certificate will be given under any circumstances.
2. If the applicant by oversight or mistake or otherwise for any other reason is admitted without recent finance year's (2021-22) OBC non-creamy layer certificate, the university/department reserves the right to cancel the admission without prior notice and without any liability.

### **Reservation for PwBD/CW/KM/PM Special Scholarship for J&K/Nominated Sikkimese Students**

- As per the provisions of Rights of Persons with Disabilities Act, 2016, not less than five percent (5%) seats are reserved for Persons with Benchmark Disabilities. "Person with benchmark disability" means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. It may be noted that the erstwhile Persons with Disability Act, 1995 under which reservation for Persons with Disabilities in admissions was provided earlier has now been repealed.

**Applicants must furnish a valid disability certificate issued by a recognized Government Hospital, bearing of photograph of the applicant.**

- Five percent (5%) of seats are reserved for applicants under **CW category**, course-wise in the college. All such applicants have to upload the Educational Concession certificate (as per the format provided in Appendix VI of the Bulletin of Information of the University of Delhi 2021-2022) to be issued by any of the following authorities on the proper letter head:
  - a) Secretary, Kendriya Sainik Board, Delhi.
  - b) Secretary, Rajya Zila Sainik Board.
  - c) Officer-in-Charge, Record Office.
  - d) 1st Class Stipendiary Magistrate.
  - e) Ministry of Home Affairs (For Police Personnel in receipt of Gallantry Awards)

**No other format shall be permissible. Proofs of the CW category in the form of ID card of parent or dependent, Medical card, Ration card, CSD card, etc. are not admissible in lieu of certificate in correct format. The priority must be clearly mentioned in the certificate. Certificates that do not mention the relevant priority will not be considered.**

- All the wards (sons/daughters) of **Kashmiri Migrants** who wish to be considered for admission to various undergraduate programs of the College have to register online as per the schedule notified by the University. Upto 5% seats are reserved course wise in the College for the wards (son/daughters) of Kashmiri Migrants. All the wards of Kashmiri Migrants will have to present a certificate of registration as Kashmiri Migrants issued by Divisional Commissioner/Relief Commissioner. Admission of Wards of Kashmiri Migrants will be based on cut-offs to be announced by the College. A concession of maximum 10% in the last cut-off marks fixed for unreserved category applicants shall be extended to the Kashmiri Migrants.
- The applicants selected under **Prime Minister's special scholarship scheme for J&K** students will be admitted directly to the College. Candidates must register on the University Portal as per schedule to be announced on University website.
- **Sikkimese students** nominated by the Govt. of Sikkim shall be considered for admission to the College (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The allocation of Sikkimese students for admission as well as for hostel accommodation in the College will be made by the Vice-Chancellor at his discretion.

### Ward, Sports & ECA Quota

- Admission to the wards of University and its College employees, both teaching and non-teaching will be done as per Academic Council resolution 9 a & b dated 27.11.2020.

**Due to the unprecedented situation of COVID-19 pandemic and prevailing public health guidelines, UG merit based admission under ECA and Sports Quota will take place without the conduct of online/offline trials.**

- The applicant seeking admission under ECA and Sports is required to register online on the University of Delhi Undergraduate Admission Portal. The allotment of Program and College to the applicant on the basis of ECA will be done in a centralized manner by the University through a centralized ECA merit list and based on the preferences of Colleges and Programs indicated by the applicant. The allotment will be based on the rank of the applicant in the order of centralized ECA Merit List, program-specific eligibility criteria, the availability of program and ECA Quota/Sub-quota in the College. Additional information regarding the schedule of ECA and Sports admissions and the availability of seats for undergraduate Admissions 2021-2022 will be notified on the University of Delhi Admission website. **An applicant submitting false/fake certificates for seeking admission on the basis of ECA and Sports shall be debarred from admission to any College for three years. Such admissions will be cancelled and strict legal action will also be taken.**

### Rechecking/Revaluation

The college may consider admission of the applicants whose marks get increased in the process of rechecking/revaluation by their respective boards; subject to availability of seats and fulfilment of the prescribed eligibility criteria in desired course till last date of admission as and when notified by the University.

## **Admission Procedure**

### **Step I: Online verification of documents by the college**

The College shall verify the documents uploaded by the applicant for eligibility and meeting the required Cut-Off.

- i. Course in-charge to verify the minimum qualifications and cut-off requirement, else to decline.
- ii. Convenor admission committee to recheck and approve the admission or decline.
- iii. Principal to approve admission for cases approved in (ii) and to confirm declining admission for those declined by the Convenor.
- iv. In case of lack of necessary documents, candidate to be contacted on email/phone so that the same may be provided. In case the candidate does not respond or where documents remain insufficient, the admission to be declined citing reason. No application will be left undecided. It will either be approved or declined.
- v. The applicants to be communicated the status of the application on their dashboard.
- vi. Those approved are required to pay the fee and receive a confirmation of their admission. Those declined admission are provided a link to raise any objection with the Grievance Committee.

### **Step II: Payment of fees to confirm admission**

Once the Principal of the College has approved their admission, the applicant will receive a link on their Dashboard on the UG Admissions portal through which they must submit the college/course fees due. This fee can only be paid online through the portal.

- i. The applicant is advised to pay the fee without delay within 24 hours of the approval of admission by the Principal of the College, and save the acknowledgement slip bearing transaction ID, Credit Card/Debit card/ Net banking details and date of transaction as a proof for future reference. On successful payment of fees, the applicant is granted provisional admission to the said college.
- ii. It is extremely important that applicants pay the fee within the timeframe allocated, failing which it will be concluded that the applicant is not interested in the course of study at that college, and the admission will be automatically cancelled.
- iii. Once the applicant has gained admission, they will have to sign an online declaration stating. "All the information provided by me are correct. In case any information provided by me is found to be false and/ or is not supported by the documents presented by me, I understand that the admission will be immediately cancelled and no fees will be refunded. I shall abide by all the rules and regulations laid down by the University and the College."

### **Step III: Verification of the original documents**

The uploaded documents will be verified by the College within the stipulated time period. If at this stage it is found that the information given by the applicant is false and/or is not supported by the documents presented, the admission will be immediately cancelled. No fees will be refunded in such cases.

(The names of applicants claiming reservation under SC/ST/OBC/EWS/CW/ KM must match with the names that appear on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates).
4. OBC (Non-Creamy Layer) Certificate (in the name of the Applicant) issued by the competent authority, and wherein the caste is in the OBC central list issued by <http://ncbc.nic.in>. (The name of the applicant claiming reservation under OBC (Non-Creamy Layer) must match with the applicant's name as it appears on their corresponding School Board qualifying certificates; similarly their parents' names must match in both sets of certificates). Income certificate for the financial year 2021- 22, dated on or after March 31, 2021, as stipulated, will be required. The format of the OBC certificate is as per the DOPT certificate issued in 2014. (Appendix VI of Bulletin of Information (2021-22) of the University of Delhi)
5. EWS Certificate (Appendix V of Bulletin of Information (2021-22) of the University of Delhi) from competent authority certifying that the applicant can claim reservation under this category. (The names of applicants claiming reservation under this category must match with the names that appear on their corresponding School Board qualifying certificates; similarly, their parents' names must match in both sets of certificates). Income certificate for the financial year 2021- 22, dated on or after March 31. 2021, as stipulated, will be required.

## Post Admission Instructions

After the filling of Admission formalities and the payment of fee on the University Portal. The candidate becomes a student of the College subject to the final approval of his/her enrolment by the University. All the fresh students are advised to procure the Students' Handbook of the College at the earliest from the Admin. office of the College to make themselves aware of their privileges, obligations, rules and regulations of the College. Apart from the details of the course wise recommended readings, text books and about various facilities in College, the Handbook covers all relevant information and therefore serves as a useful guide for academic and extracurricular needs and obligations of the students.

## Important Information for all Applicants:

- i. No direct admission shall be given to the second- and third-year classes.
- ii. No migration to this College is permitted in any of the three years
- iii. Any student submitting false/forged/fake certificates will be debarred from admission to any course, and would be liable to suitable legal action. If he/she is admitted, his/her admission will be cancelled. Such cases will also be notified to all Colleges and to the police.
- iv. In case a student gets his/her admission cancelled from any course in SRCC, he/she will not be re-admitted in the same course in SRCC.
- v. The University has decided to accept self-attested documents and papers from the students. If any false attestation/ falsified records are detected, the student will be debarred from attending any course in the University or its colleges for the next five years and in addition a criminal case under relevant Section of IPC (viz. 470, 471, 474 IPC etc.) will be instituted against him/ her.

3. Properly filled-up University Enrolment Form (available from the College office).
4. One set of self-attested photocopies of documents (listed from 5 to 9 below).
5. Certificate/Marks Sheet of Class X examination (High School) for Date of Birth.
6. Detailed marks sheet of Class XII examination/ qualifying examination.
7. SC/ST/PwBD/CW/KM/OBC (Non-Creamy Layer)/EWS/ Ward Quota/Foreign Certificate (in the name of the Applicant) issued by the competent authority (if applicable).
8. Certificate from the Head of School stating that the candidate has studied and passed Hindi subject up to Class VIII; in case candidate has not studied Hindi upto Class X and wants exemption from Compulsory Test in Hindi (CTH).
9. All the sports certificate (if applicable).
10. All the certificates mentioned above from 5 to 9 in original (all original certificates will be deposited and will be returned after their proper verification).
