## PRE-QUALIFICATION CRITERIA

The Contractors will be evaluated on the basis of following Pre-qualification criteria:-

- 1.0 The Contractor should have satisfactorily executed similar works during the last 05 years ending 31.03.2021. For this purpose, cost of work shall mean gross value of executed work.
- 1.1 **The similar works mean:** - Auditorium work which includes Acoustics Treatment, Interior works and Auditorium Chairs.
- 1.2 **Scope of Work-**The Contractor shall carry out all the works as may be required to successful completion of project which may be assigned to it on being selected through competitive bidding process. All work shall be executed as per approved drawings and certified by Architect / Engineer In Charge.
- 1.3 Minimum 5 Years of work experience to be considered with the provision of enhancement of the cost of the previous projects @ 7% per year.
- 1.4 Evaluation of the Technical Bid shall be carried out of a total of 100 marks allocated as per table in Annexure-IV. The prospective Applicant has to score minimum of 50 percent marks in each and 60 marks in aggregate to qualify. Financial bid will be open for those who are successfully qualified in technical evaluation.
- 1.5 The Contractor should have experience of having satisfactorily completed similar works during last 05 years should be either of the following:  
  
One similar work costing 80% of estimated Cost.  
  
OR  
  
Two similar work each costing 60% of estimated Cost.
- 2 **Financial Strength:** The Contractor should have Average annual financial turnover of minimum Rs 3.0 (Three) Crores for last 3 years. The requisite Turnover shall be duly certified by the Auditor with his Seal/ signatures and registration number.
  - 2.1 Net Worth of the company /firm as on 31st March of Financial Year should be positive.
  - 2.2 Bank Solvency Certificate issued from Nationalized or any Schedule Bank should be at least 80% of Estimated Cost of the Project put to tender. The certificate should have been issued in the current financial year but within 6 months from original last date of the submission of the tender.
